for applications for admission, open to male and female students (hereinafter "students") registered with Universities or University-level Schools and Institutes.

 \longrightarrow individual coaching for organizational and psychological preparation for exams, with highly qualified teachers;

 \longrightarrow access to the careers service with orientation for entering into the world of work;

 \longrightarrow courses recognized at University level that earn credits;

 \longrightarrow development of soft skills, via workshops, cultural visits, seminars and conferences, musical events and theater labs;

 \longrightarrow recreational activities including film club, parties, organized trips and group sports;

 \longrightarrow training in use of the Foundation's Library, which has more than 50,000 books and 1,300 collections of periodicals;

 \longrightarrow participation in the cultural program of the Foundation, devised by the International School for Advanced Studies in Cultural Science, the Cultural Center and the Center for Religious Studies.

COVID-19 PREVENTION PROTOCOL

The College applies strict measures to protect the health safety of residents. The Management guarantees the daily cleaning and periodic sanitation of the premises, environments, study stations and common areas. Sanitation points are available in every common area, and specific preventive kits are distributed to all residents. All spaces are set up in such a way as to allow constant compliance with safety distances even in the performance of training activities, when not carried out by videoconference. The Management constantly monitors the onset of any risk conditions, in close relationship with the medical staff and the competent health authorities.



Fees

Fee reductions

A number of merit-based fee reductions are envisaged.

\rightarrow Fee reductions paid by INPS

Under an agreement with Fondazione Collegio San Carlo, INPS makes fee reductions available to students who are the children or orphans of employees or pensioners of the Public Administration, the children or orphans of persons registered with the Support Fund for Teachers, or the children or orphans of persons registered with the Support Fund for Post and Telegraph Office workers.

The Call for Applications and Application Form will be available from the website www.inps.it. The beneficiaries will be ranked by INPS, at its sole discretion, which will notify their names to the Hall on completion of the procedures. This benefit cannot be combined with other fee reductions.

N.B. The Call for Applications requires admission to the Hall to be requested before applying for the grant, subject otherwise to loss of the latter.

\rightarrow Fee reductions paid by ENPAM

As part of the "Quadrifoglio" program of strategic assistance for doctors and dentists, Fondazione ENPAM supports the access to the University Halls of Merit through a fellowship reserved for the children (or equivalent) of its members, supporting the payment of the fee.

The Call for Applications and Application Form will be available from the website www.enpam.it The beneficiaries will be ranked by ENPAM, at its sole discretion, which will notify their names to the Hall on completion of the procedures. This benefit cannot be combined with other fee reductions.

N.B. The Call for Applications requires admission to the Hall to be requested before applying for the grant, subject otherwise to loss of the latter.

\rightarrow Fee reductions paid by Fondazione Collegio San Carlo

Students already residing in the Hall who are deemed suitable for readmission may apply for a fee reduction, which will be quantified by reference to a ranking based on their ISEE (Indicator of Equivalent Economic Situation) certificates, bound to requirements of merit and paid at the sole discretion of the Foundation (see the regulation published on the website). To participate, students must complete the relevant form and present the Combined Declaration (DSU) for the determination of their 2021 University ISEE by 15 July 2022. This grant cannot be combined with other fee reductions and is only available for rooms with floor bathroom and for places in twin rooms.

Payment method

The established fees are divided into four installments, to be paid by the following due dates:

- \rightarrow 1st installment by credit transfer upon confirmation of acceptance;
- \rightarrow 2nd installment by credit transfer by 12/09/2022;
- \rightarrow 3rd installment by credit transfer by 01/01/2023;

 \longrightarrow 4th installment by credit transfer by 01/03/2023.

Contract 6 **>**

The relationship between the Foundation and the students will be governed by:

 \rightarrow a specific contract that, in compliance with current regulations, allows access to tax deductions. Please note that the fees paid to Fondazione Collegio San Carlo (a recognized and accredited Hall of Merit) enjoy the benefits envisaged pursuant to art. 1, para. 208, of the n. 244/2007 Law (tax deductions for students living away from home). Signature of the contract is subject to acceptance of the place, as indicated in point 11;

 \rightarrow the documents attached to the Contract: A) Regulation; B) Residential and educational services; C) Learning plan; D) Privacy Policy.

Requirements for participation and selection of students

Students that meet the following minimum requirements may participate in the selection process:

 \rightarrow for students registered in the first year, high school diploma or equivalent with a score of 70/100 or more:

 \rightarrow for students registered for years subsequent to the first, registration with the University, or University-level School or Institute, and an average score for their University career of not less than 26/30;

 \rightarrow absence of illnesses that are incompatible with a communal life;

 \rightarrow absence of sentences or outstanding court proceedings for crimes.

Application for admission

The application for admission must be made using the specific computerised form available in the Hall section of the Foundation's website (www.fondazionesancarlo.it/collegio). The receipt of application must be sent by email (collegio@fondazionesancarlo.it) to the Hall Director by 10 September 2022. N.B. The Call for Applications requires admission to the Hall to be requested before applying for the grant, subject otherwise to loss of the latter.

Applicants must attach:

 \rightarrow copy of tax code and identity document;

 \rightarrow self-certification of their family status;

 \longrightarrow copy of their high school diploma (or equivalent certificate), indicating their score in hundredths;

 \rightarrow copy of the receipt confirming registration for the admission tests or courses of the University or University-level School or Institute;

 \rightarrow for students registered for years subsequent to the first, copy of the official certificate of all exams taken, with their dates and related scores;

 \rightarrow one digital passport-size photograph;

 \rightarrow copies of any other attestations or certificates of attendance or supplementary learning (language certificates, European Computer Driving Licence, diplomas issued by conservatories or academies, TOLC results);

 \rightarrow medical certificate confirming the absence of illnesses incompatible with communal life and indicating any allergies or intolerances;

 \rightarrow self-certification of the absence of any sentences for crimes.

Late applications

Applications sent after the specified deadline, which must be presented in the manner described, will be assessed using the above criteria and will take account of their chronological order of presentation, subject to availability of accommodation.

Admission test 10 -**→**

The admission test will be held on the premises of Fondazione Collegio San Carlo on a date established by Management. Further information will be provided in the Hall section of the Foundation's website (<u>www.fondazionesancarlo.it/collegio</u>). The test comprises:

 \rightarrow assessment of the certificates;

 \rightarrow interview to determine intellectual qualities, aptitudes, interests and willingness to participate in the life of the community;

 \rightarrow test to determine the level of knowledge of English;

 \rightarrow preparation of a letter giving reasons for the application.

The outcome of the test will be notified to the winning applicants within 5 working days of the date of the interview.

Acceptance of the place

The winning students will receive a communication (by e-mail) comprising notification of admission, contract of admission and indication of the amount of the installment to be sent by credit transfer to the following bank current account:

within 5 days of receipt of the communication. At the same time, students must also pay the interest-free guarantee deposit of Euro 300.00 into the same current account. This will be returned to them on leaving the Hall, less any charges for damage to the facilities or for unpaid debts, as envisaged in the Regulation.

By the same date, it is also necessary to pay the first installment of Euro 500.00, which will not be returned if the student decides not to complete the registration process.

A copy of the payment receipts must be sent to the Hall immediately by e-mail at collegio@fondazionesancarlo.it, attached to a signed copy of the contract of admission, while the original copy shall be delivered in person to the Director on arrival to the Hall. Failure to comply with these instructions will result in exclusion from admission to the Hall.

Acceptance of the place also involves signature of the documents attached to the Contract: A) Regulation; B) Residential and educational services; C) Learning plan; D) Privacy Policy.

level Schools or Institutes with a restricted intake must notify the Hall about the results of their entry tests within 2 working days of publication, subject otherwise to exclusion from admission.

\rightarrow Requirements for readmission

Applications for readmission must be made by May 31 of the academic year in progress and will be assessed at the sole discretion of Management with reference to the requirements specified in the Regulation, including:

 \longrightarrow academic performance: average score for the University career of not less than 26/30;

 \longrightarrow compliance with the Learning Plan (minimum of 70 learning hours per academic year for students in the first three years of University and 25 hours for students in subsequent years);

 \longrightarrow compliance with the Hall Regulation.

Confirmation of acceptance of the application will be notified by 15 July 2022 and by 31 July 2022 for student beneficiaries of INPS grants. The first installment of Euro 500.00 must be paid within 5 days of the confirmation date. This amount will not be returned if the student decides not to complete the registration process.

Calendar of dates: A.Y. 2022/2023

The Hall will open on September 12, 2022, and close on July 14, 2023. The Hall will be closed for Christmas (19/12/2022 - 7/1/2023 inclusive) and Easter (6 - 12/4/2023 inclusive) and 31/10/2022, 30 and 31/01/2023 (Saint's Day) 24/04/2023, 03/06/2023. If possible (compatible with the other activities of the Foundation), students may extend their stay in the Hall beyond the dates established in this Call of Applications, on payment of Euro 14.00 (for rooms with floor bathroom) or Euro 18.00 (for en-suite rooms) for each day stayed between July 15 and July 31, 2023, and in September 2022 prior to the start of the 2019/2020 academic year.
